### **Legal and Administrative Information**

### **Status and Objects**

The organisation is a charitable company limited by guarantee, number 4543199, incorporated in England and Wales on 24th September 2002 and registered as a charity, numbered 1094599, on 14th November 2002.

The company was established under a Memorandum of Association which established the objects and powers of the charitable company, and is governed under its Articles of Association. Under those Articles, all the original Trustees/Directors retired at the first AGM and have submitted themselves for re-election. Thereafter one-third have retired by rotation each year.

The financial statements comply with the Charities Act 2011, the Companies Act 2006, the Memorandum and Articles of Association, and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective January 2019).

The objectives of the charity are a) to relieve persons who are in conditions of need or hardship or who are aged or sick and to relieve the distress caused thereby in Exmouth in the county of Devon and in such other parts of the United Kingdom or the world as the Trustees may from time to time see fit; and b) to advance education by such means as the Trustees may consider appropriate including by means of establishing and operating any educational establishment or establishments in the said location and in such other parts of the United Kingdom or the world as the Trustees from time to time think fit; and c) to demonstrate the Christian faith in accordance with the ethos statement appearing in the schedule hereto in the said location and in such parts of the United Kingdom or in the world as the Trustees may from time to time think fit.

### FINANCIAL REVIEW

The income generated for the year was £219,171. The expenditure for the year totalled £202,305. This resulted in a net gain for the year of £16,866.

#### Reserves

The reserves held at 31st December 2019 totalled £96,579, broken down between Unrestricted Funds of £83,987 and Restricted Funds of £12,592.

Unrestricted reserves are made up of donations and other incoming resources receivable or generated for the objects of the charity without further specified purpose and are available as general funds. These year end reserves totalled £83,987.

Restricted reserves are made up of funds received for specific purposes as laid down by the donor. Expenditure which meets this criteria is charged to the fund, together with a fair allocation of management and support costs. These year end reserves totalled £12,592, broken down as follows:

Youth Projects: £6,602 Men's Shed: £4,127

Child Contact Centre: £1,563 Other: £300

The trustees continue to monitor the level of reserves the charity holds. We aim to hold unrestricted funds to support 6 months running costs for core activities. These have been identified as £101,000.

### **CHAIRMAN'S STATEMENT**

This picture shows just what we mean when we say, 'Open Door, at the heart of our community'. In response to our Reverse Advent Calendar Campaign, we received hundreds of donations. from local individuals, schools, churches, banks, hairdressers, shops, cafes, and other organisations - bag after bag, and box after box came in! And these are our wonderful staff and volunteers working together to sort and package it all up to send out to local individuals and families in need. 101 food and toiletries hampers and a further 86 Christmas presents given out at our Christmas Tea event. Truly inspirational.

You'll notice a new style to our Annual Report this year - still the same facts and figures, but with more photos and more quotes. We wanted to bring our report to life, to really show the difference we're making and not just tell of it. Six projects (plus a new pilot project!), 1,034 individuals supported, Open Door at the very heart of our community.

## **COMMUNITY CAFÉ**

The Community Cafe is a safe place for everyone. In a recent survey we found that 52% of our customers come in 3 times a week, and 76% come twice a week. In 2019, we saw over 10,000 customers through the doors and served 7,250 meals. We gave 572 meals away for free to the homeless and families in financial crisis during school holidays and we provided 1:1 support, advice and counselling to 395 individuals, 64 of whom were homeless. Our telephone was used 156 times for benefits enquiries, the internet used 119 time for job applications and accommodation searched and we issued 221 food larder vouchers for people in financial crisis.

As well as our in house support, this year we have also welcomed One Small Step, advising about health, Creative Minds, offering informal art therapy sessions, Exeter Community Energy, providing impartial energy advice, and Young Devon, supporting under 25s who are homeless or at risk of. We've also welcomed local community groups to meet, including a macular group, a learning disability group, and we work closely with West of England College and Robert Owen Communities ROC to welcome volunteers with disabilities to help with their enablers. It is a Community Cafe in the truest sense, run for the community, by the community, at the heart of our community!

# MEN'S SHED 2,650 VISITS

2019 has been the year of the extension for Men's Shed! While a core team have enabled the shed to continue to run as normal, we've also had an amazing building team who have constructed a new workshop and a storage/office/social area, both of which will increase capacity of the project and help ensure it's long term security. We are truly thankful to the Exeter Chiefs Foundation and East Devon District Council for funding the extension and look forward to our official opening in Spring 2020.

## PILOT PROJECT: COMMUNITY CRAFT ROOM

According to the Campaign to End Loneliness, 9 million people in the UK (almost a fifth of the population) say they are always or often lonely.

Our Men's Shed project has proven to be a great way to combat loneliness among men, so we decided to pilot a similar project open to both genders: the Community Craft Room. It is based at Clayton House Community Centre (also the location of Men's Shed), with the idea being that it offers the same principle as Men's Shed with practical projects to learn and share skills over, creating a relaxing environment to connect with other people. We've made it open to both genders and are offering a variety of crafts and activities, to appeal to varied interests, and welcoming feedback to shape the activities offered.

The Community Craft Room opened in September 2019, and in the first few months welcomed 23 people through the doors. We look forward to seeing how this project develops!

### CHILD CONTACT CENTRE

This year brought significant change at our Contact Centre as Marion Ley retired as Project Leader and we welcomed Claire White as our new leader. We are truly thankful for the legacy that Marion leaves having set up the project and helped so many families over the years and we are excited for the future as Claire takes the project forward.

In 2019, we facilitated contact for 10 families and 14 children, with many of them moving to contact in the community...

It's been a busy year for the ICE Team, providing mentoring for 49 students, The Hub open every break and lunchtime and a new Hub on the second school site, logging over 11,000 visits in total, the ICE Awards in Spring, celebrating 33 inspirational children and their families, Transition Work in Summer, helping 64 Year 6 students from 6 local primary schools prepare for the move to secondary school and reducing associated anxiety, a 38% increase on 2018 numbers, a programme of RE lessons and events reaching 440 students in the Autumn and an ICE Christmas Quiz hosted by some of our ICE Hub students!

One family came to us after the child not seeing the father for 15 months. There was a lot of stress and anxiety initially but the child and father reunited and had a great session together. After seeing the impact of that on the child, the family came back the next session with big smiles on their faces, saying they'd worked things out and would not need us anymore, as our referral and interview process, and the session itself, had helped them both to recognise what was best for the child and to work out strategies for future success.

### **ICE PROJECT**

 Tackling issues including low self esteem, friendships, home-life problems, bullying, physical health, emotional and mental wellbeing, sexuality, parental illness, separation, homework

### HAVEN

Our Haven project continues to offer a huge amount of support to young people experiencing poor mental health, supporting 58 children and young people in the last year across the three support groups: primary, secondary and young carers.

We have seen children's confidence levels improve, attitudes towards eating improve, and positive relationships forming among the group and also between children and their parents as understanding of mental health and coping strategies grows in both. Topics covered include: Stress, Worry, Fear, Anxiety, Hopes and Dreams, Relaxation, Joy, Anger, Keeping mentally healthy, Kindness, How helping others helps us, Sharing, School & Exam stress, and a range of coping strategies and Self Care,

including art therapy.

We have also been pleased to support over 40 parents through our monthly peer support and advice group for parents and carers. During the Summer Holidays we invited parents to come along and join in with a Haven session to understand what their children are doing. As one parent commented, "Now I understand why they love coming so much, it's so fun!"

At the end of 2019, we sadly said goodbye to our Haven Project founder and leader, Jenna Burnett, but we were delighted to welcome Barbara Appleby as our new Project Leader, an experienced psychotherapist, and Rachel Cock as our Support Worker, and we are very excited to see how the project develops as we go forward.

#### **OPEN DOOR EXMOUTH**

Notes forming part of the financial statements for the year ended 31st December 2019.

#### Note 1: Accounting policies

a. The financial statements are presented in pound sterling (£) and rounded to the nearest pound (£) and have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective January 2019) – (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The financial statements have been prepared under the historical cost convention, as modified by the inclusion of fixed asset investments at market value, and in accordance with SORP (FRS 102) and the Companies Act 2006. The charity meets the definition of a public benefit entity under FRS 102.

- b. Voluntary income is received by way of donations and gifts and is included in full in the Statement of Financial Activities when receivable. The value of services provided by volunteers has not been included.
- c. Grants, including grants for the purchase of fixed assets, are recognised in full in the Statement of Financial Activities in the year in which they are receivable.
- d. Incoming resources from investments is included when receivable.
- e. Resources expended are recognised in the period in which they are incurred. Resources expended include attributable VAT which cannot be recovered.
- f. Resources expended are allocated to the particular activity where the cost relates directly to that activity.
- g. Depreciation is provided at rates calculated to write off the cost of each asset over its expected useful life, which in all cases is estimated at 4 years. Items of equipment are capitalised where the purchase price exceeds £500.
- h. Investments held as fixed assets are re-valued at mid-market value at the balance sheet date and the gain or loss taken to the Statement of Financial Activities.
- i. Unrestricted funds are donations and other incoming resources receivable or generated for the objects of the charity without further specified purpose and are available as general funds.
- j. Designated funds are unrestricted funds earmarked by the management committee for particular purposes.
- k. Restricted funds are to be used for specific purposes as laid down by the donor. Expenditure which meets these criteria is charged to the fund, together with a fair allocation of management and support costs.
- l. Debtors are measured at their recoverable amounts, the amount that the charity anticipates it will receive from a debt or the amount it has paid in advance for goods and services.
- m. Liabilities are measured at their settlement amount and recognised for the amount that the charity anticipates it will pay to settle the debt or amount it has received as an advance payment for goods or services it must provide.

Provisions for liabilities are measured at the best estimate of their settlement amount.

#### Note 2: Debtors

There were Trade Debtors £528 (2018 £0). Accrued Income was £0 (2018 £3,181). Prepayments amounted £1,783 (2018 £2,519)

#### Note 3: Liabilities

Accruals for the year amounted to £875 (2018 £850). Creditors for the year amounted to £4,990 (2018 £5,271).

#### **Note 4: Staff Costs**

Total wages paid during the year were £124,116. Employer national insurance paid was £5,386. Employer contributions to pension schemes was £6,502.

No employee received emoluments in excess of £60,000 during the period. The average weekly number of employees during the year calculated on the basis of full-time equivalent was 6.

#### **Note 5: Trustee Remuneration**

The following Trustees received remuneration:

Open Door Exmouth paid Peter Chalkley £5,928 as a Project Leader.

#### **Note 6: Trustee Expenses**

No trustee expenses were incurred during the year.

#### **Note 7: Related Party Transactions**

The following related party transactions were:

Daryl Fulls – owner of Scribble & Ink and trustee of Open Door Exmouth received £2,708 for supplying stationery to Open Door Exmouth. There was no outstanding balance.

The total amount of donations received without condition from trustees or other related parties were £2,200.

#### **Note 8: Pensions**

Open Door Exmouth operated a defined contribution pension plan with the Peoples Pension. The cost for the period was £6,502 with administration fees of £476. There were no outstanding or prepaid contributions at the balance sheet date.

#### **Note 9: Taxation**

The charitable company is exempt from Corporation Tax on its charitable activities.
